India is one of the growing destinations for medical tourism as around 1.5 million medical tourists visit every year to India for their treatments. In the medical tourism industry, the leading country in medical tourism are India, Singapore, Thailand, Argentina, Malaysia and Jorden. India ranked 2<sup>nd</sup> in the world and its growing with a pace of 25% per annum in last few years. As a result, India's health tourism industry has produced the revenue of INR 1,55,650 Crore and the annual growth rate is expected to be increased by 25% in 2018. The current size of medical industry in value terms in India is estimated at a USD 3 billion. As per the study in India, states like New Delhi, Karnataka, Tamil Nadu, Maharashtra has emerged as best medical centres with good hospital and clinics. The number of foreign tourists comes for medical purposes in the year 2015 was 130,000 which increased by 50% in year 2016 which was 200,000 and till now for the year 2016-17 is about 170,000 tourists who came to India for their treatments. This clearly shows that India is the fastest growing sector in medical tourism.

Since the time of independence Indian hospitals have shown a remarkable progress only few Indians has to go to abroad for their medical treatment. Hospitals in India has specialised in both modern as well as traditional treatment, doctors are specialised in plastic surgery, heart surgery, bone marrow transplant, cancer treatment, orthopaedic treatment and eye care treatment. Difficult surgeries like bone marrow transplant, liver transplant, cardiac surgery are now regularly carried out across the country at lowest cost. The cost of medical treatment in our country is on average one eighth to one fifth of those in western countries. So, many foreigners travel to India for their treatment. India is full of trained and qualified experiences experts and doctors. Most of the doctors have their degree from abroad. Doctors in India are most knowledgeable and that help the country making a money-spinning destination for the people who want to undergo medical treatment. Hospitals in India are well equipped with advance infrastructure facilities that help in providing best treatment to patients. The share of (FTA) in India during the year 2016 among the top 25 source countries was highest from USA (17.25%) followed by UK (12.56%), Bangladesh (10.23%), Canada (5.32%), Australia (4.54%), Russia (4.10%), France (3.86%), Germany (3.43%), Sri Lanka (3.0%), Malaysia (2.99%), Japan (2.87%), China (2.55%), Korea (1.99%), Afghanistan (1.89%) and Oman (1.67%).

- 5. Brain drain from government sector to private sectors.
