The presence of women in the peace process of Afghanistan have always been associated with difficulties and doubts, as the presence of women in this process is considered as a limitation on peace process, because the opposition to the world and ideology is desirable to the presence of women in society. If historical experience has been the control of many restrictions and suffering women in the sole so that the Taliban is the way. The parties in the current peace process are not the same as the presence of participation in women's peace and participation in women's peace process. ## **5.** 4 peace supreme council

The Supreme Council of the Peace 2010 was based on a framework for launching talks with the Taliban. At this time, the Government of the Islamic Republic of Afghanistan continued to set up a national peace and compromise program to re-enlighten the middle-agent warranty in the community and providing privileges to encourage their more to leave the Taliban ranks and expanding the peace range through the process of political negotiations. (Sadat, 1398)

In this Jirga, they had more than 1,600 people. The orders of this Jirga were confirmed in the traditional Jirga, especially in the context of peacekeepers in this resolution, the League Private League resolution is one of the following 8 stressed on the preservation of female rights. The Supreme Council of the Peace made of head, the secretary, executive aspect, the spokesman, three deputies, consultants, and communications and public awareness, the provincial affairs, invitation and contact, prisoners, solving and domestic and financial committees. The council consists of 69 members, which is 9 women with women. The number of women present in this council is 12% over the whole members. The status of women in the council under the name of the Gender section is their rights and their favorites in relation to the peace process and their importance in the national reconstruction process (Research Report, 1394). In 2012, the Supreme Council of the Peace The Peace Council, which was a solution with the goals of the year, and the Panel, which has been a tall, and the other part of the war and other people, and the entire legal proclamation, and all the foreign policy has been involved with Afghanistan, and took all the foreign forces to reach Afghanistan.

The 2015 Peace Policy includes Junn's attention and other armed groups in peace talks, establishing regional relations, especially strengthening security relations between Pakistan and Afghanistan in a given time during the continuation of the peace process.

That's the solution until it was still a fruit (Sadat, 1398). The Supreme Council of the Peace Created to establish and strengthen the national consensus on political and people's elites, despite the emphasis of the strategic plan of the Supreme Peace Council (from 12 Jaza 1395 to 11 Series 1399), which the council identifies the difference between the topics of large policy-making in Kabul and Provincial elites, and the various social issues of the general public in the cities and around the role of the role, and a significant part of the people believe that the Supreme Council of the Peace Council and the intervention of the president in the policies, the affairs and the appointment of the council are the reason for the weakness of the council (Sadeer, 1388).

## 5.5 The necessity of women's participation in peace process:

- The consultation of women's participation in peace agreements.
- Considering the material proportion to gender in peace agreements.

## 5.7 equal peace is needful of women participation:

Peace without women's participation is definitely not a peaceful and fair peace, and does not have a lasting and permanent peace. Women are half the country's population and are far more than men from the war and insecurity. Therefore, the fundamental right is the women who affect and affect the events in which their affection are affected, and therefore, peace in which the vulnerable population is the illegal population is not fair, and this means that women should be in good peace.

Regarding the above reasons, women's participation in the peace process and taking into account the gender perspective is essential. If women are deprived of this stage, it is difficult to look at the next perspectives in the next stages of this perspective, gender-based and sustainable peace, the community-based and non-discrimination community (Research report, 1394).

Challenges and obstacles to women's participation in the peace process are one of the most important issues and topics of the country is the issue of peace. These findings show that the Afghan government has been recognized by the Humor for the World High Peace and Research Members, according to the European Peace Council and the provincial activists, and the provincial activists who have been under the control of the Peace and the Institute for the International Council, and the government agreed by the Afghan council and the institutions that they abandoned the underlying in the field of peace after the Afghan press, and their government has under Gering the lead for the substitution after the high pressure on the persistence of women in the field.

**Low quantity:** The number of women members of the Supreme Council and Peace Committee is very small. Of the 70 members of the council, 9 people consider it to be women. However, most women are attending the High Council and Peace Committee Participate or in the requirements of the council. This is a serious challenge. In the meetings that decide and decision-making decision, women are in a minority, and concerns about their concerns are not reflected in any way.

**Opponents of Taliban:** One of the most serious obstacles against women's participation is the opposition of the Taliban and armed opposition groups. That's why some people believe that women's participation is a serious prevention against peace and injury seriously in this process, and it may be possible with the rights of women Political transaction. Ways to women's rights are not a serious concern for the government and the Supreme Council of peace.

The rule of Taliban's mentality: as the reminder of the Special Council of Peace Council, the members of this council are arrested and epistemally close to the Taliban and the opponents. Meanwhile, at least a careful and compassion age to the Taliban and holding the Fatehou to the members of the High Peace Council, the most prominent symbol of the Taliban's mentality is the great difficulty of peace. Therefore, the mentality of the Government of the Supreme Peace is not a favorable mentality for women's participation. This mentality causes women to be marginalized and their opinions were heard less or not given the opportunity to speak to them (Research report, 1394).

**Existence Gender discrimination:** There is no one that is one of the traditional countries of Afghanistan, and the debt of the statement of this statement shows that discriminatory pills among men are members of the Supreme Peace Council, and they have the mention of men of peace and war that leads to the marginalization of women and their views. This has led to the sake of women in the peaceful and more important necessity.

The lack of strategy council implementation: While the Supreme Council's strategy strategic emphasizes 30 percent of women in the central structure and peace providers of the peace, but new changes in its structure are not reflecting this principle. With all the efforts and the prosecutors, the presence of women is now 21 percent in the council's composition, and in the provincial committee, the national unity, in particular, the State Department and the Supreme

National Council, have been fairly failing in the implementation of the National Action Plan to match the resolution of 1325, and the power of the country is a failure of the power of the national action (participation, protection, prevention and welfare). The role of women in the security institutions and the economic security, which has been challenging the current challenges to achieve their political prostitution.

**Weak partnership**: Group participants' groups discussion believe that women still do not have the decision-making power and the symbolic role. The majority of decisions on the committee of the council is taken by men and imposed on the members of the women's council. In addition to the results of the members of the Supreme Council of the Peace Council, some of the classes of the Iraqi Peace Talks have been unaware of the United States and not in the right. They did not inform these seats, and not to these meetings, which was the representative of women's participation in the peace process.

**Disagreement in taking decision and issues:** Because of the combination of several faces of the council, its members in their decisions and their basic issues in contrast to the conflict, the meaningful partnership of women in the peace process, have a different view that affects the quality of decision making and the unity of the members of the council. It is still important to cooperate and coordinate between members of the High Council of Peace and Women in the city and the village, and this has led the majority of women from different areas of institutional entity called the High Peace Council and Provincial Committees (Children Institute, 1392).

## 5.8 women achievement in high peace council:

Attracting the support and attention of world international community:

Women in the peace process have been able to meet the international support for supporting Afghan peace in general with the presence and feminity of women in this process in particular. They share their concerns and their demands with different subscriptions.

**Talking with the Taliban:** Women's High Peace Council, some civil activists in the peace process, succeeded in having a good deal with the Taliban. The meeting was placed in Norway, in which about 8 women were civilian, parliamentary and parliamentary peace council. Although he had no woman in the meeting.
